1. GENERAL PROVISIONS

These guidelines are developed in compliance with the RUDN Higher Education Educational Standard for the field of training 45.03.02 *Linguistics*, qualification "Bachelor" and determine the assessment procedure for the admission to the Master's degree programme, field of training "Linguistics" at RUDN Law Institute.

2. GUIDELINES GOAL

The goal of the Guidelines is to help people who apply for the Master's degree programme, field of training "Linguistics", specialisation "Legal Translation and Interpreting", run at the RUDN Law Institute, to systematize and improve their linguistic, translation, general humanitarian knowledge, English language proficiency, communication, and cognitive skills, educational, professional, analytical, and research experience.

3. GUIDELINES SCOPE

The purpose of the admission procedure is to assess the applicant's motivation to join the Master's degree programme, his/her previous experience in educational, research, professional activities, as well as to evaluate the applicant's applied skills in the field of translation and interpreting, and to check the applicant's competence in English for specific purposes.

The Guidelines introduce the theoretical as well as applied nature of the admission procedure, its format; educational resources to prepare for admission procedure; criteria for the results evaluation.

The components of the admission procedure ensure the objective assessment of the motivation, knowledge as well as professional training experience of the perspective students.

5. ADMISSION REQUIREMENTS

The applicant to the Master's degree programme, field of training "Linguistics", specialisation "Legal Translation and Interpreting", run at the RUDN Law Institute, is expected to master a system of knowledge and skills with regard to Linguistics, Theory and Practice of Translation and Interpreting, as well as the relevant methodology for the mentioned areas, the mentioned knowledge and skills shaped at the previous higher education level.

In the field of Linguistics, Theory and Practice of Translation and Interpreting the applicant is expected to:

know:

- conceptual and categorical apparatus of Linguistics, Translation, and Interpreting studies
- methodological foundations of the translation procedure, analysis and evaluation of both the process and its end product

be able to:

- use theoretical and methodological knowledge in the field of Linguistics, Translation, and Interpreting Studies in the course of solving practical problems of translation and interpreting in various communication contexts
- use the linguistic information presented in English and Russian texts, analyse and process it with regard to the tasks set

master

- strategies and tactics of communication in English and Russian within various situational contexts
- basic strategies and tactics of translation and interpreting within various situational contexts

- skills to apply knowledge in the field of Linguistics, Translation and Interpreting to solutions of practical tasks.

In the field of foreign and Russian languages:

The admission procedure involves checking the level of the English and Russian languages proficiency as a working languages pair for translation.

The applicants who speak other (s) foreign languages can receive additional points within the scope of the admission procedure. This advantage is obtained by the applicant who can prove the level of his/her knowledge by the certified documents in accordance with the requirements of these Guidelines.

6. ADMISSION PROCEDURE

To assess the knowledge, experience and motivation of the applicant, the assessment procedure specified in these Guidelines is implemented.

The admission procedure rests on the applicants' competitive selection.

To participate in the admission procedure, the applicants submit two packages of documents.

The first package forms the applicant's personal file and contains the documents specified in the Rules for Admission to the Federal State Autonomous Educational Institution of Higher Education *PEOPLES' FRIENDSHIP UNIVERSITY OF RUSSIA* for applicants to join educational programmes of higher education at the Master's level in 2023 (hereinafter the Rules).

The documents for the applicant's personal file shall be submitted in Russian. If the document is composed in a foreign language, it shall be translated into Russian and certified by a notary.

The second package forms the portfolio.

The admission procedure to the Master's degree programme, field of training "Linguistics", specialisation "Legal Translation and Interpreting", run at the RUDN Law Institute, is carried out through the portfolio assessment, in accordance with the procedure approved by the order of the RUDN University Rector.

To conduct the assessment, the examination board is appointed according to the University order.

The portfolio documents shall be submitted in English. Additional supporting documents may be submitted in other languages.

All the documentary evidence of the applicant's qualifications, academic results, employment experience, volunteering activities, that is fully or partially submitted by the applicant, aggregately forms the applicant's portfolio.

If the applicant submits a document that can be assessed across several portfolio items, the examination board is entitled to evaluate within one or more portfolio items at the board's discretion.

Each portfolio is evaluated by at least two members of the examination board. The points are awarded for each portfolio item and accumulated.

All the decisions of the examination board based on the evaluation results are made by a simple majority of the board members' votes. In case of equality of votes "for" and "against", the chairman of the examination board is entitled to make the final decision.

The announcement of the evaluation results takes place in accordance with the schedule for the announcement of the admission evaluation results.

The provision of the necessary resources for the evaluation procedure is carried out in accordance with the RUDN University Charter.

The knowledge assessment baseline is 30 points. The applicants who receive points below the baseline are not allowed to participate in the competitive selection admission procedure. The maximum that an applicant can reach is 100 points.

Motivation letter is a document in which the applicant:

- informs about his/her academic / professional experience relevant to a particular c master's programme

- demonstrates the applicant's ability to create a text that is characterised by the logic of narration, systematic presentation of information, as well as coherence of its argumentation
- demonstrates proficiency in formal business writing in English, and the ability to use the language individually, in order to reflect the individually meaningful choice of a particular master's programme.

Motivation letter should not exceed 6,000 characters.

6) CRITERIA FOR ASSESSMENT OF TRANSLATION ASSIGNMENT AND INTERVIEW ON ITS COMPLETION

(50 points maximum, including 30 points for translation assignment and 20 points for the applicant' comments and error analysis at the interview stage)

Translation assignment

The assignment of written translation from English into Russian (or into another foreign language that the applicant masters) of a text that focuses on legal issues and has been published in an official mass media source.

The text size is about 1000 characters, the translation time is 20 minutes.

Interview stage

After the written translation assignment being completed, the examination board checks the assignment and proceeds to the interview.

The interview aims to check the applicant's ability to critically analyse the translation process, evaluated its results, and provide necessary corrections and argumentation hereto.

During the interview, the applicant comments on the tasks during the translation process and difficulties encountered; with account of the errors indicated by the examination board, the applicant is offered an opportunity to correct them.

6) CRITERIA FOR ASSESSMENT OF TRANSLATION ASSIGNMENT AND INTERVIEW ON ITS COMPLETION

(50 points maximum, including 30 points for translation assignment and 20 points for the applicant' comments and error analysis at the interview stage)

Translation assignment

The assignment of written translation from English into Russian (or into another foreign language that the applicant masters) of a text that focuses on societal issues and has been published in an official mass media source.

The text size is about 1000 characters, the translation time is 20 minutes.

Interview stage

After the written translation assignment being completed, the examination board checks the assignment and proceeds to the interview.

The interview aims to check the applicant's ability to critically analyse the translation process, evaluated its results, and provide necessary corrections and argumentation hereto.

During the interview, the applicant comments on the tasks during the translation process and difficulties encountered; with account of the errors indicated by the examination board, the applicant is offered an opportunity to correct them.
